**RESOLUTION REDUCING SPEED LIMIT**

**A RESOLUTION OF THE TOWN COUNCIL AND  
MAYOR OF GERALDINE, ALABAMA REDUCING  
SPEED LIMIT:**

**WHEREAS**, the Mayor and Town Council of the Town of Geraldine, Alabama have determined it would be in the best interest of the safety and welfare of the citizens of the Town of Geraldine, Alabama, and those travelling upon the roadway, for the speed limit on that portion of DeKalb County Road #52, which portion is located within the town limits of Geraldine, Alabama, to be reduced from the current speed limit of 45 miles per hour to a speed limit of 35 miles per hour.

**NOW THEREFORE**, it is **RESOLVED** as follows:

1. For the best interest of the safety and welfare of the citizens of the Town of Geraldine, Alabama, and those travelling upon the roadway, the speed limit on that portion of DeKalb County Road #52, which portion is located within the town limits of Geraldine, Alabama, hereby is reduced from the current speed limit of 45 miles per hour to a speed limit of 35 miles per hour effective immediately.
2. The Mayor hereby is authorized to cause new signs to be posted upon the roadway reflecting the new speed limit of 35 miles per hour, and to otherwise notify the public through posting notices, or publication, or both, of the new speed limit.

Further, Mayor Chuck Ables and Donna Johnson, the Geraldine Town Clerk, are the proper officers to execute and attest this Resolution, and shall execute and attest the same.

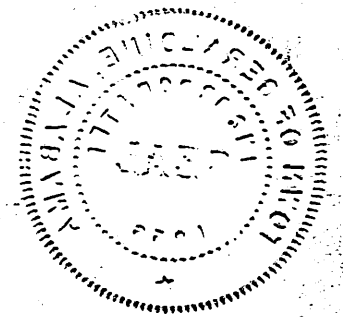
