**SEVERE WEATHER PREPAREDNESS SALES TAX HOLIDAY**

A RESOLUTION OF THE TOWN OF GERALDINE, ALABAMA, TO EXEMPT CERTAIN "COVERED ITEMS" FROM THE MUNICIPAL SALES AND USE TAX BEGINNING AT 12:01 AM ON FRIDAY, FEBRUARY 26, 2016 AND ENDING AT TWELVE MIDNIGHT ON SUNDAY, FEBRUARY 28, 2016 AS AUTHORIZED BY ACT 2012-256, GENERALLY REFERRED TO AS THE STATE SEVERE WEATHER PREPAREDNESS SALES TAX HOLIDAY LEGISLATION.


BE IT ORDAINED BY THE TOWN OF GERALDINE, ALABAMA AS FOLLOWS:

**Section 1.** In conformity with the provisions Act 2012-256 enacted by the Alabama Legislature, providing for a State Severe Weather Preparedness Sales Tax Holiday, the Town of Geraldine, Alabama, exempts "covered items" from municipal sales and use tax during the period, beginning at 12:01 am on Friday, February 26, 2016 and ending at twelve midnight on Sunday, February 28, 2016.

**Section 2.** This ordinance shall be subject to all terms, conditions, definitions, time periods, and rules as provided by Act 2012-256, except that the time period shall only be as specified in Section 1 above and not for all years thereafter.


**Section 3.** The Town Clerk is hereby authorized and directed to certify a copy of this ordinance under the seal of the Town of Geraldine, Alabama and to forward said certified copy to the Alabama Department of Revenue to be recorded and posted on the Department website.


